
You are requested to take following actions:

Furnish a Performance Security in the form of a Bank Guarantee as specified and in the amount of **US\$ 22, 344, 113.39 (twenty two million three hundred forty four thousand one hundred thirteen dollar and thirty nine cents)** within **twenty eight (28) days** of issuance of this Notification of Award but not later than 27/01/2020 in accordance with ITT Clause 69.2.
- iii. Sign the Contract within **twenty eight (28) days** of issuance of this Notification of Award but not later than 27/01/2020 in accordance with Sub Clause 73.2.

You may proceed with the execution of the Works only upon completion of the above tasks. You may please note that this Notification of Award shall constitute the formation of this Contract which shall become binding upon you.
