- furnish a Performance Security in the specified format and in the amount of Tk 1,43,29,848.00 (Taka one crore forty three Lakh Twenty nine thousand eight hundred forty eight only), within 14 (fourteen) days of receipt of this Notification of Award but not later than 20/01/2020, in accordance with ITT Clause 64.2
- sign the Contract within twenty-eight (28) days of issuance of this Notification of Award but not later than 02/02/2020 in accordance with ITT Clause 67.2
- complete following activities within 60 (sixty) days from the date of issuance of Notification of award (NOA):
 - To take approval of SPC pole design and drawing specification from BPDB;
 - To manufacture 03 (Three) No's of SPC Pole for each item as per approved design and drawing and shall have to complete Tests in presence of BPDB representatives.

On the basis of comments of BPDB representative, if tests result is found satisfactory, Supplier shall manufacture and supply all the SPC Pole as per approved design and drawing. If Test result is not found as satisfactory, Performance Security submitted as per ITT 63 shall be encashed and contract will be terminated for default. (ITT Clause-63.1, GCC cluse-40 & 30.1)

You may proceed with the execution of the supply of Goods and related Services only upon completion of the above tasks. You may also please note that this Notification of Award shall constitute the formation of this Contract, which shall become binding upon you.

We attach the draft Contract and all other documents for your perusal and signature.


