7. Winning Bidder and Duration & Summary scope of the contract awarded

China Petroleum Pipeline Engineering Company Limited (CPP) and China Petroleum Engineering and Construction Corporation (CPECC), Joint Venture, China is the winning Bidder for the above package of this project and their offered price exclusive of Tax & VAT is USD 61,301,484.00 and BDT 433,480,504.00 (total equivalent BDT is 5,631,846,347.20) and inclusive of Tax & VAT is USD 63,009,595.00 and BDT 503,774,640.00 (total equivalent BDT is 5,846,988,296.00). Completion for the whole of the Facilities shall be within 540 days from the Contract Effective Date. The Contractor shall perform the EPC (Engineering, Procurement & Construction), 1 year of Operation & Maintenance Service and 1 year of Defect Liability period for this Project. The Contractor's obligations cover the provision of all Plant and the performance of all Installation Services required for the design, the manufacture (including procurement, quality assurance, construction, installation, associated civil works, pre-commissioning and delivery), the installation, completion, and commissioning of the Facilities in accordance with the plans, procedures, specifications, drawings, codes, and any other documents as specified in the Employer's Requirements, and in accordance with good engineering practice and all applicable laws and regulations.
