

on the day of August, 2021.


BETWEEN

- (1) Department of Livestock Services, Ministry of Fisheries and Livestock, represented by Project Director, Livestock and Dairy Development Project (LDDP), having its principal place of business at Building No.: 2, Level-7, Department of Livestock Services, Krishi Khamar Sarak, Farmgate, Dhaka-1215, Bangladesh. (hereinafter called "the Purchaser"), of the one part, and
- (2) Itochu Corporation, a company incorporated under the laws of Japan and having its principal place of business at 5-1, Kita-Aoyama 2- Chome, Minato-Ku, Tokyo, 107-0061, Japan (hereinafter called "the Supplier"), of the other part:

WHEREAS the Purchaser invited Bids for certain Goods and ancillary services, viz., Procurement of 119 Nos.  - (f) the Specification (including Schedule of Requirements and Technical Specifications)
 - (g) the completed Schedules (including Price Schedules)
 - (h) any other document listed in GCC as forming part of the Contract
3. In consideration of the payments to be made by the Purchaser to the Supplier as specified in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other



sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
