- ii. furnish a Performance Security in the specified format and in the amount of BDT 1,88,64,504.00 [one crore eighty eight lac sixty four thousand five hundred and four taka] or equivalent USD (as per Bangladesh Bank rate on the date of issuance of this NOA), within Twenty-eight (28) days from issue of this Notification of Award but not later than 08 December 2021, in accordance with ITT Clause 64.3.
- iii. sign the Contract within twenty eight (28) days of issuance of this Notification of Award but not later than 08 December 2021, in accordance with ITT Clause 69.2

3. You may proceed with the execution of the supply of Plant and Services only upon completion of the above tasks. You may also please note that this Notification of Award shall constitute the formation of this Contract, which shall become binding upon you.
