

# Contract Agreement

THIS AGREEMENT made



BETWEEN

- (1) Department of Livestock Services, Ministry of Fisheries and Livestock, represented by Project Director, Livestock and Dairy Development Project (LDDP), having its principal place of business at Building No.: 2, Level-7, Department of Livestock Services, Krishi Khamar Sarak, Farmgate, Dhaka-1215, Bangladesh. (hereinafter called "the Purchaser"), of the one part, and
- (2) Bangladesh Science House, a company incorporated under the laws of Bangladesh and having its principal place of business at H # 27, Amtoli (Airport Road), Mohakhali, Dhaka-1212, Bangladesh (hereinafter called "the Supplier"), of the other part:

WHEREAS the Purchaser invited Bids for certain Goods and ancillary services, viz., Contract No.: LDDP/G-39, Lot-3, entitled "Procurement of Laboratory Equipment for Improvement of Existing Laboratory of Department of Livestock Services (DLS)" and has accepted a Bid by the Supplier for the supply of those Goods and Services with contract amount of USD 181,420.00 plus BDT 1,325,150.00 plus BDT 1,440,000.00 (In words: one hundred eighty one thousand four hundred twenty US Dollar plus one million three hundred twenty five thousand one hundred fifty Bangladesh Taka plus one million four hundred forty thousand Bangladesh Taka).   - (f) the Specification (including Schedule of Requirements and Technical Specifications)

  - (h) any other document listed in GCC as forming part of the Contract
3. In consideration of the payments to be made by the Purchaser to the Supplier as specified in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.


