

1. The price of 19 (Nineteen) Types of Machinery Hand Tools is CFR, Chattogram **USD 19,666.38** (USD Nineteen Thousand Six Hundred & Sixty Six Point Three Eight) only (FOB Value **USD 19,274.58** and Estimated Sea Freight Charge **USD 391.80**).
2. Letter of Credit shall be established under any suitable source of fund through Bangladesh Chemical Industries Corporation (BCIC), Dhaka, Bangladesh in accordance with the rules and regulations governing the import policy of Bangladesh. **Payment will be released after successful completion of Post Landing Inspection (PLI) at AFCCCL Site.**
3. Shipment of 19 (Nineteen) Types of Machinery Hand Tools will be completed within **12 (Twelve) Weeks** from the date of L/C opening and Port of Shipment must be any sea port in Spain.
4. The Country of Origin must be Spain and Manufacturer must be EGA Master S.L, Spain
5. Furnish a Performance Guarantee (PG) from any scheduled bank of Bangladesh in the Specified format (**Form PG4-11 attached**) amounting **USD 2,000.00** (USD Two Thousand Only) and submit to the office of the undersigned positively on or before **June 17, 2026** with a validity up to **December 31, 2027**.
